Aliye Talal Mosaad, Social Affairs Officer, works in the Programme on Ageing Section at the United Nations Department of Economic and Social Affairs (UNDESA) in New York. In this role, her work revolves around supporting and servicing intergovernmental processes of the General Assembly, the Economic and Social Council, and the Commission for Social Development. She aims to expand the mainstreaming of ageing related issues across the UN system and with relevant stakeholders including civil society and the private sector. Previously at UNDESA, Aliye



worked as an Associate Expert with the Programme on Youth Unit, also gaining relevant social development policy experience. Before joining the UN, Aliye cultivated extensive experience in Saudi Arabian diplomacy, undertaking roles in both the United Arab Emirates and the United States. While in

the United Arab Emirates, she conducted and published research on the diabetes epidemic, exploring its connection to demographic transitions, socio-economic trends, and policy impacts on healthcare systems. Aliye is currently a doctoral candidate in public health, working on her dissertation research at the State University of New York, Downstate Health Sciences University. Her research focuses on thermoregulatory stress and the ageing mind, focusing on environmental high heat exposure as a risk factor for dementia. Within academia, Aliye has many years of experience in research having worked as a research assistant focused on the epidemiology of ageing, and as a graduate teaching assistant focused on health policy. This work has deepened her understanding of the cumulative role of social determinants of health across the life course and the importance of using reliable data to inform policymaking. Aliye received her Bachelor's degree from the University of Virginia, a Professional Graduate Certificate from Harvard University in Business Economics, and a Master of Public Health degree from the University of South Florida.

Ms. Silvia Quan, national of Guatemala, feminist, expert on the rights of persons with disabilities. Holds degrees in Chemistry and in Mathematics; M.A. in Human Rights; postdiplomacy in Gender Studies. From 2003 - 2013 led the disability rights defense unit within the Ombudsman's Office in Guatemala. 2013 - currently: Has been an independent consultant for several INGOs: HI (former Handicap International), CBM, and the International Disability Alliance (IDA); collaborating advisor for the Disability Rights Fund

(DRF), consultant for the Inter-American Institute on Disability and Inclusive Development (IIDDI), Trickle-Up Guatemala, Save the Children, World Bank and IFAD, the Latin-American network of OPDs (RIADIS) and diverse national OPDs and NGOs. From 2011-2016 served as independent expert on the UN Committee on the Rights of Persons with Disabilities, during its last two years 2015-2016 was its Vice-Chairperson. From 2017-2019 held the position as Senior Human Rights Advisor for the International Disability Alliance (IDA), office in Geneva. From 2019-2022 Senior consultant for the initiative on preventing and eliminating violence against women and girls with disabilities and their access to justice, co-implemented by LEGIS and Colectivo Vida Independiente de Guatemala. Currently: President of "Colectivo Vida Independiente de Guatemala" Member of the Board – Disability Rights International (DRI).
